APPENDIX B

Application for Adult Business License

The applicant, _____, hereby applies for:

- an adult business license in Richland Township.
- renewal of an adult business license in Richland Township.

1. The applicant is a(n):

If the applicant is an individual, please state his/her legal name and any aliases in the spaces provided below and submit proof that he/she is at least 18 years of age (e.g., driver's license).

If the applicant is a partnership, the partnership shall, in the spaces provided below, state its complete name, and the names of all partners, whether the partnership is general or limited, and attach a copy of the partnership agreement, if any, to this application.

If the applicant is a corporation, the corporation shall, in the spaces below, state its corporate name, the date of its incorporation, evidence that the corporation is in good standing under the laws of its state of incorporation and qualified and authorized to conduct business in Pennsylvania, the names and capacity of all officers, directors and principal stockholders, and the name of the registered corporate agent and the address of the registered office for service of process.

CONDUCT

2. If the applicant intends to operate an adult business under a name other than that of the applicant, he or she must state:

- (a) The adult business's fictitious name; and
- (b) Submit the required registration documents.

3. If the applicant who wishes to operate an adult business is other than an individual, each individual who has a 20% or greater interest in the business must sign the application for a license as applicant. Each such person must individually meet the qualifications for an adult business license, and each applicant shall be considered a licensee if the license is granted.

4. In the spaces below, please state whether the applicant, or a person residing with the applicant, has been convicted of a specified criminal activity, as defined by Chapter 6, Part 5, of the Code of Richland Township and, if so, the specified criminal activity involved, the date, place and jurisdiction of each. Provide any pertinent available criminal history record information.

5. In the spaces below, please state whether the applicant, or a person residing with the applicant, has had a previous license under this ordinance or other similar adult business ordinance from another municipality, state or county denied, suspended or revoked, including the name and location of the adult business for which the permit was denied, suspended or revoked, as well as the date of the denial, suspension or revocation, and whether the applicant or a person residing with the applicant has been a partner in a partnership or an officer, director or principal stockholder of a corporation that is licensed under this ordinance whose license has previously been denied, suspended or revoked, including the name and location of the adult business for which the permit was denied, suspended or revoked, as well as the date of denial, suspension or revocation.

6. The spaces below, please state whether the applicant or a person residing with the applicant holds any other licenses under this ordinance or other similar adult business ordinances from another municipality, state or county and, if so, the names and locations of such other licensed businesses.

7. In the spaces below, please identify the specific classification of adult use for which the applicant is filing and provide a detailed description of each and every activity encompassed by the proposed adult business. The detailed description shall thoroughly demonstrate compliance and/or intended compliance with all provisions of Chapter 6, Part 5, of the Code of Richland Township.

8. In the spaces below, state the location of the proposed adult business, including a legal description of the property, street address and telephone numbers, if any. Please separately attach the legal description.

9. In the spaces below, please provide the applicant's mailing address and residential address, daytime and nighttime phone numbers and fax numbers.

10. Please attach to this application a recent photograph of the applicant(s), clearly showing the applicant's face, and the applicant's fingerprints on a form provided by any police department. Any fees for the photographs or fingerprints shall be paid by the applicant.

11. In the spaces below, please provide the applicant(s) driver's permit number, social security number, and his/her state or federally issued tax identification number.

12. Please attach to this application a sketch or diagram showing the configuration of the premises, including a statement of total floor space occupied by the business. The sketch or diagram need not be professionally prepared, but it must be drawn to a designated scale or drawn with marked dimensions of the interior of the premises to an accuracy of plus or minus six inches.

13. Please attach to this application a current certificate and straight-line drawing, prepared within 30 days prior to the filing of the application, as prepared by a registered land surveyor, depicting the property lines and the property to be certified.

If the applicant wishes to operate an adult business which includes viewing booths, as defined by Chapter 6, Part 5, of the Code of Richland Township, the applicant shall provide additional information required by and comply with the requirements of Chapter 6, Part 5, of the Code of Richland Township and shall separately apply for and obtain a building and occupancy permit for the installation of viewing booths, as required.

The undersigned applicant(s) for an adult business license in Richland Township do/does certify that he/she has read and do/does understand the requirements and provisions of Chapter 6, Part 5, of the Code of Richland Township which provides for the licensing and regulation of adult businesses and employees and which prescribes fees, fines and penalties for violations. The undersigned applicant(s) for an adult business license do/does hereby agree to comply with all requirements and provisions of Chapter 6, Part 5, of the Code of Richland Township. The applicant(s) do/does further certify that the information provided in this application is true and accurate. The applicant is aware that the failure to provide information reasonably necessary for issuance of a license or providing false information is a basis for denial of the license.
