

Richland Township Parks and Recreation will be introducing a new online program called Civic Rec.



Richland Township Parks and Recreation is very excited to announce our new on-line registration website for program information, facilities, updates and easier registration process for participants. We are hoping that by having this feature, our participants do not have to spend time over and over filling out registration forms for programs, finding time to stop in the office, or mailing in forms. This new program will allow you to register right from your computer, phone or tablet, without any hassles. You will have the ability to register, pay online with a credit card, and get a confirmation that you are registered for the event. **Note:** Credit cards have a 2.85% fee attached to each transaction.

This service is provided to reduce the impact of leaves on the municipal stormwater system, streams and wetlands.

All bags must be out prior to 6:00 a.m. on the day of pick up.

Only biodegradable paper bags may be used.

Please limit each bag to 40 lbs.

Tree trimmings that are no larger than 3 inches in diameter and smaller than 48 inches in length must be tied/bound into manageable bundles.

PLASTIC BAGS ARE NOT PERMITTED!

What should I do after a tick bite?


FOLLOW THESE TIPS IF YOU FIND A TICK ON YOURSELF OR SOMEONE ELSE:

REMOVE THE TICK AS SOON AS POSSIBLE.

Use tweezers or a tick spoon to remove ticks quickly and safely, lift straight up.

Do not worry if the head remains in the skin after removal, the abdomen is the part of the tick that carries disease.

Clean the area around the bite with soap and water or rubbing alcohol.



IDENTIFY THE TICK IF POSSIBLE.

Dog ticks in Maine are known to carry human disease.

MONITOR FOR SYMPTOMS FOR 30 DAYS AFTER A DEER TICK BITE.

Symptoms to monitor:

Lyme Disease: bullseye rash, headache, fever, chills, joint pain.

Anaplasmosis: fever, headache, lack of appetite, nausea, muscle pain, vomiting.

Babesiosis: fatigue, sweating, dark urine, chills, fever, anemia.

Powassan: headache, body ache, fever, vomiting.

Antibiotics are **not** routinely recommended without symptoms.

Antibiotics are **not** effective for preventing **or** treating Powassan.

Payment is due at the time the application is made. The new system will accept credit cards. No phone reservations will be taken. Payments are accepted in the form of cash, money order or check. Applications will be accepted from both residents and non-residents. (A non-resident fee is still in effect.)

Richland Township Christmas Tree Pick Up



Winter is Coming - Remember, Only Rain Down the Drain!

Winter snow often puts a pristine white coat over every surface that makes for beautiful photos and lots of family fun. However, it's not long before the sun comes out to expose a host of issues created by the melting snow. Just like when rain falls the rest of the year, melting snow turns into stormwater runoff. Heavy rains sweeping across your yard and driveway carry pollution and high volumes of water into our nearby streams, lakes, and other waterways. Melting snow does the same things. Both rain and snow melt can seriously impair Pennsylvania's waters when they travel over the land in our developed communities. They can also cause significant property damage at your home.

In winter, melting snow actually causes a few unique stormwater problems. Because the ground is often frozen at the surface, melting snow can't infiltrate into the soil the way a light or moderate rain would be able to. So even a small amount of snow can cause localized flooding on your property. When snow builds up over several small storm events without melting in between, it can turn into large winter storm impacts when it finally does melt leading to potential community wide flooding events. In both cases, that standing and flowing water on the ground is picking up all kinds of debris, pollutants (especially de-icing salts and chemicals), and litter that will find their way into nearby streams.

Here are some tips for managing your property for winter stormwater this season:

- ♦ When piling your snow after shoveling and plowing, choose locations where the snow will have the most opportunity to infiltrate instead of becoming stormwater runoff. Pile your snow in areas where you don't usually have ponding in the spring rains, on relatively flat areas, and away from sensitive areas like streams, ponds, and your private well if you have one.
- ♦ Clear your downspouts to allow melting roof snow to flow and not collect at your foundation.
- ♦ Make sure your nearest storm drains are clear. Do not pile snow on storm drains and make sure your neighborhood plow is not piling snow over the drains too. Clear away any snow that may have been kicked onto the drains by passing cars.
- ♦ Use de-icing chemicals and salts judiciously. Use what you need to make your walkways and driveways safe, but try to avoid spreading around sensitive areas like waterways and your private well.

WINTER IS RIGHT AROUND THE CORNER

The Richland Township Public Works Department is responsible for the winter maintenance of approximately 69 miles of Township streets. Our seven-man crew does their best to keep those streets passable during winter storm conditions. In some storm situations, this can be a daunting task.

You Can Help! Parking of vehicles on roadways during winter maintenance operations can make it very difficult for our trucks to maneuver and can result in some areas being un-plowed or treated. Often we have to request assistance from the police department to get vehicles moved just so our trucks can travel through to complete their designated routes. This causes delays and can add to hazardous conditions. There is also the concern of one of our trucks sliding on untreated roadways and colliding with vehicles that are parked on the roadway. In addition, shoveling snow from your walk or driveway out on to the roadway can cause hazardous conditions. If the route has been plowed and treated, depending on conditions, it may not be re-treated or plowed for many hours. Snow that is pushed or shoveled onto the roadway can re-freeze creating traffic hazards as well as extra work for an already stretched crew.

Your cooperation with these issues will greatly assist in our operations.


