#### **Discussion Items**

- 1.1 John welcomed everyone and members introduced themselves.
- 1.2 John provided a brief overview of the meeting agenda as follows:
  1. Brief review of project scope of work
  2. Discuss your thoughts on Active Transportation vision and goals for Richland Township

  4. Review draft of mapping

  7. Identify/confirm existing & perceived barriers to walking, and biking.

- 1.3 John reviewed the project scope of work and schedule, attached. He indicated the work will take about 7 months to complete. He said their goal is to complete the plan before the holidays.

1.4 John and Heather asked attendees who the key stakeholders are in the Township that we need to speak with, responses included:

1.5 Heather asked attendees to identify one to three people that they think we should be speaking to, and to provide names and contact information to her by the end of June.

1.6 John handed out and reviewed a draft of the on-line active transportation questionnaire, attached. Attendees provided comments and feedback on the questionnaire, John will revise the questionnaire and provide another draft to the committee for review. Please return your comments on the revised draft questionnaire to Heather by the end of June.

1.7 Ray asked how the survey will be advertised. Heather and John said that it should be posted on the Township website, and on the website of others who would be willing to link to it, Library, etc. Further, it should be advertised through social media. Melissa said the Township does not have a social media presence.

Heather suggested utilizing other groups in the Township to spread the word through social media, i.e., Library, sports organizations, community groups and clubs, churches, etc. Heather also said Pashek will provide Melissa with flyers that can be posted in the park, library, post office and other key locations in the Township.

Pashek+MTR will also provide posters, maps, and other information to Melissa to display at the Township Community Day. Poster will include a QR code with a link to the questionnaire. Ro suggested handing out business cards at Community Day with information on how to access the questionnaire. Pashek will provide Melissa with business cards to hand out at community day.

1.8 John reviewed the draft maps. These maps are as follows and include the corresponding information:

1.10 John handed out a map titled Overall Strategic Recreation Plan, attached, from the 2010 Recreation Plan. John indicated that it showed, at a high level, the Township's desire for connectivity throughout the Township. John provided it as food for thought, and we will discuss it further at the next meeting.
